MEMBERSHIP

EPR has two main types of membership, Regular membership and Observer membership. Observer membership is either a two-year trial period for organisations considering regular membership, or for organisations that don't fulfil the regular membership criteria.

There are three fee levels, dependent on the GDP of the country in which an organisation is based. Observer membership is 50% of the regular fee. Guest membership allows short term participation in activities in order to discover what we offer.
