There are approximately 80 million citizens with disabilities in the EU, who often face barriers that prevent them from fully participating in all aspects of life on an equal basis with others. In its commitment to eliminate these barriers and improve the life of people with disabilities, the EU became a party to the UN Convention on the Rights of Persons with Disabilities (UN Convention). Implementing the Convention is an ongoing process and it is a shared responsibility of the EU institutions and the Member States. The EU can only act within the powers conferred to it by the EU treaties. A first review of the EU's implementation of the UN Convention, done by the UN Committee on the Rights of Persons with Disabilities, recognised the progress achieved until now, but also provided some recommendations for the future.

At EU level, the UN Convention is implemented through the European Disability Strategy 2010-2020. This Strategy has identified eight main areas for action at EU level: Accessibility, Participation, Equality, Employment, Education and Training, Social Protection, Health and External Action. Having reached the halfway point in its implementation, the European Commission launches this public consultation in order to assess its impact and to ensure EU policy remains tailored to the needs and rights of persons with disabilities.

This questionnaire asks for your opinion on what has been achieved so far at EU level, your views on the challenges faced by all persons with disabilities and how the European Union should address them. We appreciate all replies from citizens, organisations, public authorities, businesses, academics and other stakeholders.

We will use the findings of this public consultation to assess the progress made under the European Disability Strategy 2010-2020 and to identify gaps to be addressed at EU level to ensure the full and equal participation of persons with disabilities in society.

To improve implementation of initiatives and aims of the European Disability Strategy we call for a greater recognition of the role of services to persons with disabilities and a greater involvement of such service providers. In the planned work on employment and reasonable accomodation it is important to engage service providers who have experience of partnerships with employers for integrating people with disabilities in the workplace, to share good practice and dispel stigma. EPR offers the expertise of its members in this field. It is also important to showcase good practice in community-based services, particularly services funded by the ESIF. We call for a renewed Guide to Social Considerations in Public Procurement, to include highlighting the opportunities for measures that support people with disabilities and good practice in this field, as well highlighting the possibilities for and benefits of contracting high-quality social services. The Commission should continue to promote the Voluntary Quality Framework for Social Services, particularly among public authorites. We call on the Commission to develop a strategy to ensure that the European Semester contributes positively to the implementation of the UNCRPD, including in the AGS, Country Report analyses and CSRs. The social investment approach must continue to be promoted and supported by the European Commission, to ensure access to quality services to all people who are in need of care or support.
