What is this study about?



This document is about independent living.

It tries to help people understand better what independent living is and how to make it happen.

What is Independent Living?

Independent living is a right.

Independent living means:



- You can choose where to live.
- You can choose who to live with.
- You have support when you need it.
- You can make decisions about your life.
- You have the same chances as other people.

It does not mean doing everything alone.

It means getting help to live the way you want.

Everyone needs some help sometimes.

People with disabilities have the right to choose what help they want.



What do persons with disabilities need to live independently?

Housing



In institutions many people live together.

They do not have choices.

They do not decide what to do each day.

People need their own safe accessible homes.



Homes should be in the community,
not separated from where most people live.

People should be able to pay for their own homes.

Support

People need support in their own homes,
in the community.

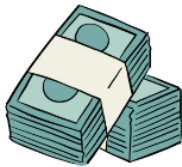


People can get help from personal assistants.

Personal assistants help people with their daily activities.

Money

People need enough money to live, for example



- for food
- housing
- and support.

Accessible services

For example,
you should easily be able to



- Use buses.
- Go to shops.
- Get health care.
- Go to a regular school.



Decisions

You should have support to help make decisions if you need it.

You have the right to say no.



Training and education

You should have chances to learn new skills and to find work that you like.



Friends and community

You should be able to be part of their community, have friends and do activities you enjoy.

What are governments doing?

Many European countries are changing their services.

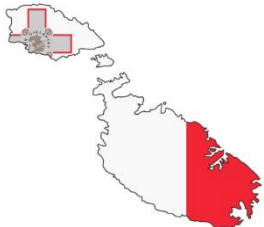
Spain

Spain made a plan to change from institutions to community support.



The plan includes:

- Training for people working in support services
- Money for new services
- Homes in the community



Malta

Malta is making big changes to disability support.

They are introducing personal budgets.

Personal budgets let you choose how you spend money for your support.



Sweden

Sweden has strong personal assistance.

People choose who helps them.

They say when and where they need help.

Examples of support services

The examples can give ideas to other organisations, about how they can support independent living.

Why is Independent Living not Happening?

Money



There is often not enough money from government for services in the community or personal assistants.

Money is still spent on institutions.



Housing

There are not enough accessible, affordable homes.

Services

Some places do not have services in the community.

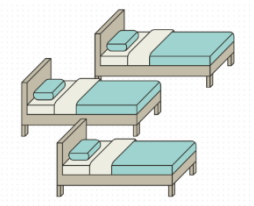
Attitudes



Some people think people with disabilities cannot live independently.

This is not true.

Planning



Services are sometimes organised around how many people live together, Not on what people need

Complicated systems



Sometimes health services and social services do not always work together.

This can make it hard to get support.

What needs to change?

Governments need to:



- Make laws that protect the rights of persons with disabilities
- Give more money to community services
Help health and social services work together

- Stop building new institutions
- Make sure housing is accessible

Organisations providing services need to:



- Listen carefully to persons with disabilities.
- Help people make their own decisions.
- Train the people working in the organisation about rights.
- Work with families and other services.
- Tell the government what persons with disabilities need.

Communities need to:



- Understand that persons with disabilities can live independently
- Welcome and include persons with disabilities.
- Help create accessible services and buildings.

The EQUASS programme

EQUASS helps organisations that work with persons with a disability.

It gives them advice about how to help people live independently.

Organisations can be tested to see if they follow all the advice.

Final message

With the right support,
and everyone working together,
persons with disabilities
can live independently.
