Independent Living

- Older than UN Convention on the Rights of Persons with Disabilities (UNCRPD)
- UNCRPD Article 19 Living independently and being included in the community
- UNCRPD General Comment 5 on Article 19
 Independent Living means that individuals with disabilities are provided with all necessary means to exercise choice and control over their lives.
- European Commission Guidance on Independent Living
 Persons with disabilities are supported towards autonomy and participation
 & are empowered to make the same choices and have same control over their day-to-day as everyone else in society.

EU Funds for Independent Living: European Commission Guidance

- Published 11/2024
- Recommendations to Member States on using EU funding to accelerate transition from institutional care to community-based services & independent living in 6 key areas.
- How EU funds (e.g. ESF+, ERDF) can finance accessible social housing, community-based services, personal assistance, staff training, strategic national plans towards deinstitutionalisation.
- Self-assessment tool on alignment of funded projects with independent living approaches.





Recent Commitments to Independent Living Made by EU Governments

17 October 2025 "Council Conclusions on the Social Inclusion of Persons with disabilities through the promotion of Independent Living"

Social inclusion of persons with disabilities (in public session)

Ministers approved conclusions on the social inclusion of persons with disabilities through the **promotion of independent living**.

To support independent living of persons with disabilities, older people, children, people experiencing homelessness & those with mental health issues.

- Prevention of institutionalisation dynamics
- Participation & awareness
- Transforming care & support models
- Developing services for transition to living in the community
- Enabling conditions for DI

Malta's Deinstitutionalisation and Independent Living Strategy

To transform disability-related services and processes:

The EQUASS Framework: Essential Elements for Organisations to Facilitate Independent Living

Framework tailored to the social sector designed to assure quality services and facilitate continuous improvement.

From childrens' services to support for older people.

Sections: "Leadership and Governance", "Quality Management and Improvement", "Workforce Management and Development", "Rights and Dignity" and "Empowerment and Person-Centredness".

Organisations seeking EQUASS certification undergo an audit process to demonstrate compliance with each criterion's requirements. These requirements address essential elements for services committed to enabling and promoting independent living.

EQUASS: Essential Elements for Organisations also Include...

- Rights Awareness
- Co-production
- Supported Decision-Making
- Quality of Life Orientation
- Autonomy & Self-Advocacy
- Social Inclusion

- Human rights-based approach
- Coordinated and Continuous Support
- Safeguarding & Privacy
- Accessible Services & Environments
- Workforce Training
- Addressing Rights Concerns

Recommendations - EU level

- Ensure respect of the CRPD among the MFF's Horizontal Principles
- Preserve earmarked funds for social objectives
- Establish stringent EU fund allocation oversight
- Strengthen monitoring of the partnership principle
- Develop inclusive monitoring indicators
- Facilitate EU-wide innovation and capacity-building initiatives
- Fund implementation of key EU disability initiatives (including the Framework for Social Services of Excellence for Persons with Disabilities)
- Ensure implementation of independent living policies and practices feature strongly in the updated Strategy for the rights of persons with disabilities

Recommendations - National/Regional/Local level

Funding and Contracting:

- Long-term funding commitments
- Unified funding mechanisms
- Flexible budgets
- Funding to implement quality assurance frameworks
- Prioritise quality in competitive public tendering processes
- Reward quality certification in public contracts

Systems Integration and Coordination:

- Formal mechanisms enabling integrated support at highest level
- Frameworks to facilitate coordinated service provision
- Data-sharing agreements



Recommendations - National/Regional/Local level

Transitions

- Earmark funding for services supporting independent living
- Use EU funds for transitions to community-based services
- Carefully consider individuals with severe or complex disabilities
- Ensure support to service providers if funding model changes
- Provide support to the community
- Implement regulations to ensure accessible and affordable housing

Workforce

- Ensure attractive wages and working conditions
- Support professional development on independent living and related concepts
- Recognition of peer support roles



Conclusions

- The knowledge is there, the understanding is not?
- Challenges are often systemic
- Breaking the cycle requires change across multiple levels: cultural, political, financial, organisational, and professional.
- Need to build an environment that sustains commitment
- Broad collaboration between sectors is needed, including at EU level, building alliances
- Showcasing what is possible and what has been achieved is key
