



# What's now and what's next? Practices and Policies in the Employment of People with a Disability

This webinar is co-organised by the European Platform for Rehabilitation (EPR) together with Rehabilitation International Finland (RIFI) in the context of EPR's National Awareness Raising Event (NARE) series. The aim of this event is to examine the state of play, developments and successes in both practice and policy supporting the employment of people with a disability. It will address initiatives at the European and national levels, examining the current and possible future impact and implementation of national and EU policies on practice and programmes.

Session 1 comprises an overview on employment practices for people with a disability in Europe and the lessons learnt from a recent study, and will familiarise the participants with EPR's perspectives on employment of people with a disability as well as key developments at EU level<sup>1</sup>. A national example looking at Finland's co-production approach to employment of people with a disability will follow. The three presentations will be followed by Q&A with the audience.

Session 2 will make a "tour d'Europe" and involve speakers from Belgium, France, Norway and Spain to present inspiring practices and programmes supporting the employment of people with a disability to be later discussed with participants.
