# 1. DEVELOPMENTS IN TECHNOLOGY & POLICY



### DIGITAL ACCESSIBLE AND ASSISTIVE TECHNOLOGY IN FOCUS

**Assistive technology -** umbrella term covering the systems and services related to the delivery of assistive products and services.

**Assistive technology:** Hearing aids, wheelchairs, communication aids, spectacles, prostheses, pill organizers and memory aids are all examples of assistive products.

**Digital assistive technologies** rely on more recent scientific and technological advances to help disabled people access digital services including smart home technology

Assistive products maintain or improve an individual's functioning and independence, thereby promoting their well-being.












### CHAT GOES ONLINE DURING COVID TO SUPPORT SERVICES GOING VIRTUAL



A systems map is a diagram to show what is in and outside of your system from your perspective


Plenty of paper!

Also important to know what is outside of your boundary


