European Association of Service Providers for Persons with Disabilities: Suspension of Structural Funds to Portugal and Spain will hit disadvantaged most

On the 3rd of October, the European Parliament discussed with the European Commission about their proposal to suspend part of the European Structural and Investment Funds (ESIF) for Portugal and Spain in 2017, as part of their non-compliance with the European Union's budgetary rules. In a letter to Members of the European Parliament, EASPD – alongside the Social Platform and Social Services Europe – strongly opposes the suspension of any ESI fund which supports human rights enjoyment, labour market integration and social inclusion.

With this revision, the Commission aims to simplify and modernise these tools for the digital age and to add a new feature using big data to map and anticipate labour market trends and skills needs.

Employment and Social Developments in Europe - Quarterly Review - Autumn 2016

This review confirms the strengthening of employment growth in the EU observed over the last two and a half years. Employment increased in almost all Member States (except for Croatia, which registered a small decline, and in Finland where it stagnated). Unemployment is at its lowest rate (8.6%) since March 2009, with 1.6 million (0.7 pp) fewer unemployed people in the EU compared to last year.

Statement by Vice-President Ansip and Commissioner Oettinger welcoming the adoption of the first EU-wide rules to make public sector websites and apps more accessible

European Commission Vice-President Andrus Ansip, responsible for the Digital Single Market, and Commissioner Günther H. Oettinger, in charge of the Digital Economy and Society, welcome the decision by the European Parliament to formally approve the Directive on the accessibility of the websites and mobile applications of public sector bodies.

Vice-President Ansip and Commissioner Oettinger said:

"Everyone should benefit from the opportunities offered by the internet and fully participate in the digital society. Today's adoption is an important step in the right direction. New rules will ensure that people with disabilities – especially blind, deaf and hard of hearing persons – can more easily access and use the websites and mobile applications of public services.

Today's adoption is the culmination of several years of hard work with the European Parliament and Member States. We have particularly appreciated the strong engagement of associations representing the disabled community and consumers. Their help in preparing the Directive greatly contributed to the quality of the legislation. We will ask the European Standardisation Organisations to quickly develop the harmonised standard on the accessibility requirements required for the Directive.

The rules adopted today are part of the Commission's ongoing work to build an inclusive European Union. We proposed in December 2015 the European Accessibility Act - with common accessibility requirements for ATMs and banking services, PCs, telephones and TV equipment, telephony and audio-visual services, transport, e-books and e-commerce. More recently, we also proposed draft legislation to implement into the EU law the Marrakesh Treaty. The aim of this Treaty is to facilitate access to published works for persons who are blind, visually impaired, or otherwise print disabled. We rely on the

European Parliament and Member States that to show equal support for these proposals and to adopt them swiftly."

ILGA-Europe: It's official – France adopts a new legal gender recognition procedure!

The French parliament has voted to introduce a legal gender recognition procedure that is free from sterilisation and medicalisation. The National Assembly met in a plenary session on Wednesday 12 October to debate and vote on the 21st century justice law (La loi sur la justice au XX1eme siècle), which included provisions relating to legal gender recognition.

Under the updated process, trans people will no longer have to be sterilised before being legally recognised in their true gender. In addition to this, there will be no requirement to provide proof of medical treatment, as had been proposed in amendments introduced by the Senate several weeks ago. Emancipated minors will also be able to access the updated procedure.

Juncker Commission presents third annual Work Programme: Delivering a Europe that protects, empowers and defends

The Commission Work Programme for the coming year focuses squarely on delivery of the 10 priorities outlined in the Political Guidelines in order to address the biggest challenges which Europe faces today.

On the basis of the Work Programme, the Commission, European Parliament and Council will now work on a Joint Declaration on commonly agreed objectives and priorities for 2017, to swiftly turn proposals into action and bring concrete results for citizens.

President Jean-Claude **Juncker** said: "We are focusing on the things that matter, concrete actions that improve people's lives. With the 60th Anniversary of the Rome Treaties coming up next March, we must unite around a positive agenda. This is what the Commission's Work Programme is about. In the comings weeks I will – together with the European Parliament and Council – select a number of initiatives of major political importance that should receive priority treatment in the legislative process in the months to come. This is the Europe that delivers."

Close to EUR 2.4 million awarded to support cultural projects for integration of refugees

In response to the refugee situation in Europe and in line with the Commission's Action Plan on integration of third country nationals under the European Agenda on Migration, the European Union, through its Creative Europe programme, has awarded over EUR 2 million in funding for cultural projects to help refugees integrate into European societies. The transnational projects will involve 62 organisations in 20 countries. The organisations involved come from a whole range of sectors, including creative writing, publishing, libraries and museums, dance, music, theatre, digital arts, film, video, graphic arts, painting, drawing and photography. The projects will focus on promoting mutual cultural understanding, intercultural and interreligious dialogue, tolerance and respect. They will primarily seek to tell the stories of refugees, but many also focus on refugees working with host communities to promote the sharing of experiences. The projects will be led by organisations from Croatia, Denmark, France, Italy, Poland, Spain, Sweden and the United Kingdom.
