

Opera Don Calabria starts new projects

'Locomotor Impairments and Rehabilitation in Infantile Cerebral Palsy' is the title of the Opera Don Calabria Innovative Research Project officially launched on 15 February 2008 with the aim of develop new rehabilitation strategies and technologies for the best exploitation of recovery potentialities in patients suffering from Infantile Cerebral Palsy (ICP). The two years project will focus on the ODC children users and will be developed in cooperation with 4 Faculties of the University of Verona and the Catholic University of Rome.

In January the Veneto Region assigned to ODC the experimental project on 'Comprehensive services to people with disabilities in a sustainable system' the project focuses on ways of social care and assistance to adults with disabilities of the Region and aims to define (or re-define) common assessment tools to adults with disabilities and to overcome the huge differences within the Region and to build a common and sustainable model of system at regional level.

Two Ministers visit Durapart

On 25 January 2008, the Minister of Labour and Social Inclusion, Bjarne Håkon Hansen and Minister of Government Administration and Reform, Heidi Grande Røys visited Durapart AS. The purpose of their visit was to learn more about quality assurance of social services, the project 'Patient in Activity" (PIA) and Durapart's focus on helping long-term recipients of social benefits into having a more active life and find ordinary work. The Ministers were particularly interested in learning about Durapart's work on motivating young, unemployed people (18-25) for an active lifestyle. This



work is focused on practical areas like starting every day with a healthy breakfast and newspapers to be better informed and integrated into society. In our opinion a healthy diet combined with physical activity has have a positive effect on sleeping habits, and this provides the necessary energy and strength to start working. In an eight week program, a majority of the 15 participants adopted an active lifestyle, and 3 participants found ordinary work. The Ministers declared that they would recommend this programme nationwide. The Ministers spoke with youths while two of the most recognised TV-channels in Norway were filming them.

Astangu opens sheltered workshop

At the end of 2007 Astangu Vocational Rehabilitation Centre opened a small sheltered workshop. There has been need for sheltered workshop for years. The main reason is that many graduates are not ready to enter open labour market after they have completed the training at Astangu Centre. They may need time to adjust to work life or they don't get job right away after the graduation and there is a need to keep them active until they gain employment. The clients work in sheltered workshop with a services contract. In addition to Astangu Centre's own students and graduates we also plan to have clients referred by Labour Market Board in the framework of employment service offered by the Labour Market Board. They will receive funding from Labour Market Board. Most of the jobs involve packing: disposable tableware, seeds, etc. But there was a nice offer from a cable company that enables our clients to try out product development. The cable company provides us with the remains of their products and our clients can come up with and implement the ideas for company gifts.

Centre Action Plans (CAPs)

CAPs implementation well under way

The 2nd generation of CAPs (2007-2008) is half-way through its implementation process, a key phase during which an interim evaluation is conducted. This evaluation has been based on centre visits organised in the end of 2007 and beginning 2008 and during which Jan Spooren and Jan Albers have met the persons involved in the Action Plan of their centre.

These meetings were very helpful in collecting feedback on the past year's activities and fine-tuning the activities in 2008 according to the centres' needs. Moreover, these visits provided an excellent opportunity of maintaining a direct contact between the EPR secretariat and the professionals of the centres.

In total, 12 joint activities and 20 individual activities are planned for 2008. This represents a significant increase in comparison to 2007, but is in line with the EPR work plan 2008 clearly prioritises the CAPs and the services to members. With the financial support of the Structural Funding EPR receives from the European Commission since 2008, it also became possible to involve more experts and consultants in the CAP activities, which should still increase their quality.

EPR Seminar on 'Ageing Workforce & Disability'

In February, EPR organised a one-day Training Seminar in Brussels on the theme of 'Ageing Workforce & Disability'. The Seminar was attended by 25 participants from 13 countries. It was facilitated by Dr Richard Wynne from the Work Research Centre in Ireland.

Knowledge Management Centre (KMC)

KMC improvements

After a one year break for the KMC activities, the EPR secretariat works at full speed on technical and methodological innovation to offer fresh and attractive features to EPR members.

The objective is to promote the KMC among professionals and to integrate the use of this tool in their usual references for searching information. The main improvements are:

A full text search

The KMC will display an optimised functionality for searching information which is similar to the research function of Google. This functionality increases the volume of information found and presents the research results by order of relevance.

Launch of a database section on experts

This new section will be dedicated to information on the experts from EPR centres. This section will help the EPR members to find experts available for consultancy services or projects in quick and easy way.

These innovations will be presented at the KMC meeting on 10 April and will be finetuned during the coming months according to the meeting conclusions.

EPR Innovation Prize

EPR is pleased to announce you the launch of an Innovation Prize. The Prize rewards a practice in the EPR network which would be the most innovative and valuable to the rehabilitation sector. The Prize aims to promote innovation and support mutual learning through knowledge management.

All professionals from EPR members are invited to participate via the EPR Knowledge Management Centre (the database can be accessed via a password at http://epr.eu/kmc), and insert information on a good practice in his/her centre in the standard templates of the database. The best practice will be selected by the KMC administrators and upon pre-defined criteria.

The Prize will be granted during the EPR Annual Conference. The professional who has inserted the awarded practice in the KMC will receive of voucher of **1.000 Euro** for travel and participation to EPR professional development activities.



Reintergrate project kicks-off

EPR has commenced a new project entitled 'Integrated e-learning for managing job retention and return to work' (acronym: Reintegrate) aims at developing tools to upgrade the skills and competences of employers on how to prevent employees at risk of disability to lose their work. The project consortium is made up of 5 organisations:

- Work Research Centre Ltd (WRC), Ireland (project leader)
- Irish Business and Employers Confederation (IBEC), Ireland
- European Platform for Rehabilitation (EPR), Belgium

- EWORX SA, Greece
- National Institute for Disability Management and Research (NIDMAR), Canada.

In addition to these partners, six centres will be involved in the project under the leadership of EPR. They will collect feedback from employers on the developed tools. These centres, include 5 EPR members and are the following: CRPG, Portugal; ODC, Italy; Heliomare, the Netherlands; Institute for Rehabilitation in Slovenia; Durapart, Norway and the Centre for Regional and Social Resource in Hungary.

The project started on 1 November 2007 and it is due to end in 31 October 2009.

The centres have already undertaken their first tasks, which consisted in providing their own views via interviews on the specific skills and knowledge in disability management that the future tools should address.

The project partners are currently reviewing the centres feedback in order to make a first draft of the tools content which will be discussed with all partners during a project meeting on 14-15 of April in Athens.

Public Affairs

EPR attends Disability High Level Group meeting

In March, Jan Spooren, General Secretary and Jeronimo de Sousa, President represented EPR at the meeting of the *High Level Group on Disability* (*HLG*) The HLG is essentially composed of senior civil servants from the EU Member States and key NGOs in the sector . It meets three times a year to develop and discuss the priorities of the EU Disability Action Plan.

The March meeting, co-chaired by the new *Head of the EC Disability Unit, Mr Johan Ten-Geuzendam,* addressed important issues such as the implementation of the UN Convention, the new State Aid Block Exemption Regulation being currently drafted and Social Services of General Interest and public procurement. The HLG two-year work programme was also rolled out.

In relation to fostering accessibility to the labour market where only supported employment was mentioned, EPR stressed the importance of other services such as vocational training and disability management.

EPR Seminar on Social Services of General Interest

In January, EPR hosted a Working Seminar focused on the issue of **Social Services of General Interest (SSGI)**. The Seminar brought together several partners of the informal network of NGO social service providers that EPR has joined.

The Seminar was organised in follow-up to the EC Communication on SSGI adopted in November 2007. Debates focused on the SSGI which refer to enhancing legal certainty in the field of SSGI and to the promotion of quality. The partners also reviewed two accompanying documents concerning the application of state aid and public procurement rules to SSGI.

Following the event, EPR has produced an extensive Analysis Report on latest developments around SSGI. You can find this paper on the EPR website.

Rebranding

Following approval by the EPR Board of Directors, the name EQUIP was replaced with **EQUASS**. This rebranding overcomes a number of challenges and confusions identified in the Sales & Marketing strategy.

EQUASS stands for *European Quality in* **Social Services** and all the certification levels have been named according to the *'brand name'*.

EQUASS Assurance (formerly EQUASS)

- guarantees quality of service provision

EQUASS Excellence (formerly EQRM)

- guarantees excellence in social services

EQUASS Award

- New EQUASS certification programme that will be launched in May 2008. It has been developed to promote the Principles for Quality in the social sector and to identify and award *outstanding performance* on these Principles.

During the first month in 2008 extra efforts have been made to adapt the existing EQUASS documentation as well as to develop a brand new set of PR materials.

Capacity-building

To assure continuity in development, management, coordination, sales and marketing an EQUASS Core Group has been set up. The EQUASS Core Group has the objective to learn and to review the different aspects and developments of the EQUASS unit. The Group members are: Guus van Beek (EQUASS Manager), Jana Kukuckova (EQUASS coordinator), Michael Crowley (Rehab Group), Karl Wiggo Jensens (Durapart AS), Jean Claude Schrepfer (CRM) and Antinio Riho (CRPG).

News from the EQUASS Licence Holders

The Association of Vocational Rehabilitation Enterprises (AVRE) signed the Local Licence Holder Agreement (LLH) for Norway in December 2006. An increasing interest for EQUASS As-

surance has been noticed during 2007, both from AVRE member companies and from the Norwegian authorities. It is likely that external certification will become a requirement for all organisations in the rehabilitation sector in Norway. The Norwegian Licence Holder AVRE expects an increase of interest and requests for certification for EQUASS Assurance in 2008.

The **Association of Social Services** (LOS) signed the LLH Agreement for Denmark in November 2007. LOS has since that date worked out a general plan for introduction, promotion and implementation of EQUASS Assurance for the Danish market for 2008. This plan contains the following actions:

- Translation of EQUASS materials into Danish Language.
- Informing key stakeholders in Denmark (including the Ministries of Social Affairs, employment and Welfare) about the initiative of LOS to introduce EQUASS Assurance into the Social Sector.
- Building up capacity to run the EQUASS Assurance system in Denmark: training of EQUASS Assurance auditors and EQUASS consultants.
- 4. Organisation of information events for Service Providers in the Social Sector.
